ORDER

On January 13, 2022, Big Rivers Electric Corporation (BREC), Kenergy Corporation (Kenergy), and Kimberly-Clark Corporation (Kimberly-Clark) filed motions requesting certain witnesses participate virtually in the January 20, 2022 hearing in this matter. As a basis for the requests, parties noted the risks and restrictions associated with the COVID-19 pandemic. Additionally, all requests note that virtual participation of witnesses will not prejudice any other party or the Commission. Kenergy also requested counsel, Christopher Hopgood, be allowed to participate virtually because of the COVID-19 concerns.

Based upon the motions and otherwise being sufficiently advised, the Commission finds that BREC, Kenergy, and Kimberly-Clark established good cause to grant the motions for witnesses and counsel for Kenergy to participate virtually in the January 20, 2022 hearing in light of the COVID related health concerns raised in the motions.

IT IS THEREFORE ORDERED that:

1. BREC's, Kenergy's, and Kimberly-Clark's motions requesting that witnesses be permitted to participate virtually in the January 20, 2022 hearing are granted.

2. Kenergy's motion to allow counsel, Christopher Hopgood, to participate virtually in the January 20, 2022, hearing is granted.

3. Commission Staff shall contact participants with instructions for participating virtually.
