ORDER

On March 14, 2022, McCreary County Water District (McCreary District) filed a motion in the above-named proceedings requesting a ten-day extension of time in which to file its comments to the Commission Staff's Reports (Staff Reports) that were filed in these proceedings on March 11, 2022. In support of its motion, McCreary District stated that its comments on the Staff Reports are due on March 25, 2022, and that any comments made by McCreary District to the Staff Reports will require the approval of McCreary District's board of commissioners, but that the next regularly scheduled meeting of McCreary District's board of commissioners is March 29, 2022.

Further, McCreary District stated that it has previously waived its right to place its proposed rates into effect subject to refund and that therefore, the proposed extension of time will not enable McCreary District to place the proposed rates into effect prior to the Commission's final decision on the proposed rates.

Based upon a review of the motion and the case record, and being otherwise sufficiently advised, the Commission finds that McCreary District established good cause

for a 10-day extension of time in which to file its comments the Staff Reports in these proceedings. The Commission finds that the motion is granted.

IT IS THEREFORE ORDERED that:

1. McCreary District's motion for an extension of time is granted.
2. McCreary District shall file its comments on the Staff Reports in these proceedings on or before April 4, 2022.
3. Nothing contained in this Order shall prevent the Commission from entering further Orders in this matter.
