ORDER

On March 22, 2024, Graves County Water District (Graves District) filed a motion requesting an extension of time until April 12, 2024, to submit its response to Commission Staff's Second Request for Information (Staff's Second Request) dated March 15, 2024. Pursuant to Staff's Second Request issued by the Commission on March 15, 2024, Graves District was to file responses to Staff's Second Request with the Commission on March 29, 2024.

Graves District stated in its motion that personnel from Mayfield Electric and Water Systems (MEWS), who are contracted to perform Graves District's operations, management and accounting, whose assistance is needed to respond to the requests, are unavailable until the week of April 1, 2024, due to previously scheduled vacations. Likewise, Graves District's auditor is unable to immediately assist in preparing Graves District's response and will require additional time to provide some of the requested information. Accordingly, Graves District requested a 14 day extension, until April 12, 2024, to respond to Staff's Second Request.

Having considered Graves District's motion and given that personnel from MEWS and Graves District's auditing firm are currently unable to assist Graves District in providing the requested information, the Commission finds that good cause exists to grant an extension until April 12, 2024, to file its responses to Staff's Second Request dated March 15, 2024.

IT IS THEREFORE ORDERED that Graves District's motion for an extension of time is granted.
