ORDER


On March 11, 2022, Kenergy Corp. (Kenergy) filed a motion seeking an extension of time until March 21, 2022, to file rebuttal testimony. In support of its motion, Kenergy stated that its counsel's schedule has prevented it from submitting adequate testimony by the March 11, 2022 deadline established by the Commission's October 22, 2021 Order.

Based upon a review of the motion and the case record and due to the importance of having a robust record upon which the Commission will render its decision, the Commission finds that Kenergy established good cause to grant it an extension of time to file its rebuttal testimony. Therefore, the Commission finds that the motion is granted.

IT IS THEREFORE ORDERED that:

1. Kenergy's motion for an extension of time is granted.
2. Kenergy shall file its rebuttal testimony on or before March 21, 2022.
