I am hearing that you will be having a meeting in regards to the implementation of rural internet by Kenect and Kenergy in the near future. I am in rural Daviess county and have access to AT&T U-Verse through the normal landline, however the service is insufficient to support my work from home status..

If there are any challenges from an entity due to an area being "Served" already I would expect the commission to understand that just because a company says the area is "Served" that it also understand that the statement needs to be clarified. AT&T had my service for years until it was determined that my speeds were a fraction of what was promised in my contract, due to my residence being at the end of the line. That statement however didn't reduce my bill because I was already at the lowest option that would support my needs. I have tried to get better service from all of the normal Internet Service Providers but since I am in a rural area the infrastructure expense couldn't be justified.

The requirement for more work from home and at home learning for kids will continue to grow as we face these issues in the future.

The addition of this new source of internet coverage would be greatly beneficial to all consumers including those within the "Served" areas, as it would drive competition, forcing those private companies that are over charging for services to compete.
