On January 25, 2022, XOOM Energy Kentucky, LLC (XOOM) was granted intervention in the above referenced case. XOOM is an affiliate of NRG Energy, Inc. (NRG). On March 25, 2022, Mr. Travis Kavulla, of NRG, filed testimony on behalf of XOOM in this matter.

Mr. Kavulla, separately from his employment with NRG, teaches a course at the Harris School of Public Policy at the University of Chicago on utility regulation. Prior to his involvement in this matter, Mr. Kavulla sought assistance from the Chairman of the Commission, Kent A. Chandler, in the form of providing a guest lecture to his class and judging a mock rate proceeding participated in by his students.
