ORDER

On June 3, 2022, XOOM Energy Kentucky, LLC (XOOM) filed a motion to reschedule the hearing previously scheduled for June 15, 2022, due to the unavailability of its witness Travis Kavulla. In support of its motion, XOOM stated that it had coordinated with Interstate Gas Supply, Inc. (IGS), Constellation New Energy, Gas Division, LLC, (CNEG), and Columbia Gas of Kentucky, Inc. (Columbia Kentucky), and none of those parties had an objection to the motion. Further, XOOM stated that the next available date for all parties is September 29, 2022.

The Commission notes that no party will be harmed by the requested continuance, because the Commission issued an Order on March 17, 2022, continuing Columbia Kentucky's CHOICE program under its current terms and conditions until a final Order is entered in this proceeding. Generally, the Commission does not look favorably on requests for continuance. However, here XOOM has represented that the parties to this proceeding agree to the request.

Based upon the motion and the joint agreement of the parties, the Commission finds that XOOM has shown good cause to continue this preceding. The Commission

finds that the formal hearing in this matter shall be rescheduled for September 29, 2022, at 9 a.m. Eastern Daylight Time.

IT IS HEREBY ORDERED that:

1. XOOM's motion is granted.
2. The hearing scheduled for June 15, 2022, at 9 a.m. Eastern Daylight Time, in the Richard Raff Hearing Room of the Commission's offices at 211 Sower Boulevard in Frankfort, Kentucky is canceled.
3. A hearing in this matter shall be held on September 29, 2022, at 9 a.m. Eastern Daylight Time, in the Richard Raff Hearing Room at the offices of the Public Service Commission.
4. Columbia Kentucky shall give notice of the hearing in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, [psc.ky.gov](http://psc.ky.gov)"; and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, [psc.ky.gov](http://psc.ky.gov)." At the time the notice is mailed, or publication is requested, Columbia Kentucky shall forward a duplicate of the notice and request to the Commission
5. The September 29, 2022 hearing shall be recorded by digital video recording only.


