ORDER

On July 1, 2022, Sierra Club moved the Commission to admit *pro hac vice* Kristin A. Henry is admitted *pro hac vice* for the purpose of representing Sierra Club in association with Joe Childers in the above-styled proceeding, provided that Joe Childers or another member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.
2. Kristin A. Henry shall comply with the rules of the Commission and the Kentucky Bar Association.
