ORDER

On February 17, 2022, the Attorney General of the Commonwealth by and through the Office of Rate Intervention (Attorney General) filed a motion requesting Lawrence W. Cook be permitted to participate virtually at the hearing scheduled for March 1, 2022, through March 3, 2022. J. Michael West and John G. Horne III will be present in-person at the hearing. As a basis for this request, the Attorney General noted the risks and restrictions with the ongoing COVID-19 pandemic. The Attorney General asserted virtual participation of Mr. Cook would not prejudice the Commission or any other parties.

Based upon the motion and being otherwise sufficiently advised, the Commission finds that the Attorney General established good cause to grant the motion to allow Mr. Cook to participate virtually in the March 1, 2022, through March 3, 2022, hearing in light of the COVID-19 related concerns raised in the motion.

1. The Attorney General's motion for counsel to participate virtually in the March 1, 2022, through March 3, 2022, hearing is granted.
2. Commission Staff shall contact participants with instructions for participating remotely.
