ORDER

On December 17, 2021, Kentucky Utilities Company (KU), Nolin Rural Electric Cooperative Corporation (Nolin RECC), and East Kentucky Power Cooperative, Inc. (EKPC) (collectively, the Joint Movants) filed a motion requesting that the Commission schedule an informal conference (IC) to give an overview of the application, the requests contained in the application, and the reasons for such requests; that Joint Movants will have representatives of the Joint Movants available to answer the questions of Commission Staff and any intervening party regarding the requests and any other aspect of the application; and to brief the Commission on the status of and construction of the project described in the application.

The Commission finds that the purpose of the IC to answer questions from Commission Staff and brief Commission Staff was rendered moot due to information contained in the application and responses to data requests, and therefore the request is denied.
