ORDER

On January 18, 2022, Bluegrass Gas Sale, Inc. (Bluegrass) filed an application for an adjustment of its rates. The Commission entered an Order on January 25, 2022, setting a procedural schedule for data requests and responses. On February 25, 2022, Bluegrass filed a motion requesting an extension of time to respond to Commission Staff's First Request for Information (Staff's First Request), which was filed on February 10, 2022, with responses due February 25, 2022. As a basis for the requests, Bluegrass stated that it is in the process of gathering the data necessary to respond to the Staff's First Request and requested an additional five business days to file its responses. Pursuant to the original procedural schedule, supplemental discovery requests were due March 11, 2022; however, Bluegrass has not filed its responses to Staff's First Request. There are no intervenors in this proceeding.

The Commission finds that Bluegrass has shown good cause to grant the extension of time to respond to Staff's First Request. The Commission further finds that the procedural schedule shall be amended. An amended procedural schedule is set forth in the Appendix to this Order.

IT IS THEREFORE ORDERED that:

1. Bluegrass's motion for an extension of time to file responses to Staff's First Request is granted.

2. The procedural schedule set forth in the Commission's January 25, 2022, Order is canceled and replaced with the procedural schedule set forth in the Appendix to this Order.

3. All other provisions of the Commission's January 25, 2022, Order remain in full force and effect.
