ORDER

On April 14, 2022, the Commission issued an Order authorizing Louisville Gas and Electric Company (LG&E) to incur debt subject to the terms and conditions outlined in the Order. The April 14, 2022 Order inadvertently included a typographical error in the date in ordering paragraph 1.

Finding that the April 14, 2022 Order shall be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Ordering paragraph 1 of the April 14, 2022 Order is stricken and is replaced with the following language:

LG&E is authorized to issue long-term debt in the form of First Mortgage Bonds, Intermediate Term Financings, or a combination of both, in an aggregate principal amount not to exceed \$700 million, from the date that this Order is entered through December 31, 2023.

2. All other provisions of the Commission's April 14, 2022 Order that are not in conflict with the terms of this Order shall remain in effect.
