ORDER

This matter arises upon South Hopkins Water District's (South Hopkins District) request for an extension of time to file certain documents. On January 31, 2022, the Commission authorized South Hopkins District to borrow no more than \$60,000 to replace a service truck destroyed by a tornadic event in December 2021. In that Order, the Commission required South Hopkins District to file a verified form of its request within ten days that the Order was issued. On February 10, 2022, South Hopkins District requested an extension of time to make that filing. The Commission will treat the request as a motion, which is attached as an Appendix to this Order. As a basis for the request, South Hopkins District explained that, due to an ice storm, its regularly scheduled board meeting was canceled and rescheduled to Tuesday, February 15, 2022.


Based upon the request, the Commission finds that South Hopkins District established good cause to extend the time to file the verified filing, and thus the motion is granted. South Hopkins District shall file a verified form of South Hopkins District's January 20, 2022 letter within 15 days of the date of this Order.

IT THIS THEREFORE ORDERED that:

1. South Hopkins District's motion for an extension of time is granted.

2. Within 15 days of the date of this Order, South Hopkins District shall file a verified form of South Hopkins District's January 20, 2022 letter that is signed under oath in compliance with KRS 278.300(2).
