ORDER

The Commission's March 31, 2022 Order, pursuant to 807 KAR 5:056, Section 1(11), initiated the six-month review to examine Kentucky Power Company's (Kentucky Power) application of its Fuel Adjustment Clause from May 1, 2021, through October 31, 2021. As part of the review, Kentucky Power was ordered to file with the Commission, no later than June 17, 2022, responses to requests to information in Commission Staff's Third Request for Information (Staff's Third Request) filed on June 7, 2022. Kentucky Industrial Utility Customers, Inc., (KIUC) is the only intervenor in this matter.

On June 17, 2022, Kentucky Power filed with the Commission a motion requesting an extension of three business days (through and including June 22, 2022) in which to respond to Staff's Third Request, Item 2. As grounds for its motion, Kentucky Power stated that it requires additional time to complete and confirm its substantive response to the remaining unanswered data request. Kentucky Power stated that granting the short extension will not result in any prejudice to the Commission or KIUC in this matter.

The Commission finds that Kentucky Power has presented sufficient grounds for its motion to be granted and that granting the extension will not result in prejudice or undue delay.

IT IS THEREFORE ORDERED that:

1. Kentucky Power's motion for an extension of time in which to file responses to Staff's Third Request, Item 2 is granted.

2. Kentucky Power's responses to the Staff's Third Request, Item 2 shall be due no later than June 22, 2022.
