ORDER

On October 24, 2022, Telesto Energy Project LLC (Telesto) filed a motion for witness Yosef Shirazi, PhD to be permitted to testify virtually at the hearing scheduled for November 1, 2022, at 9 a.m. Eastern Daylight Time. Counsel and all other witnesses for Telesto will be present at the hearing. Telesto stated that virtual participation of this witness would not prejudice the Siting Board.

Based upon the motion, and otherwise being sufficiently advised, the Siting Board finds that Telesto has established good cause to grant the motion to allow Dr. Shirazi to participate virtually in the November 1, 2022, hearing scheduled in this case. The Siting Board further finds counsel for Telesto shall contact Siting Board Staff to schedule a technology test to ensure that there will not be problems with the witness' virtual participation.

IT IS THEREFORE ORDERED that:

1. Telesto's motion to allow Dr. Shirzi to participate virtually in the November 1, 2022 hearing is granted.

2. Siting Board Staff shall contact participants with instructions for participating remotely.
3. Before October 31, 2022, counsel for Telesto shall arrange a technology test with Siting Board Staff to ensure that all required technology is working properly.
