ORDER

On July 14, 2022, East Kentucky Power Cooperative, Inc. (EKPC) filed a motion for an extension of time to file responses to initial requests for information, which were due to be filed no later than July 21, 2022, per the initial procedural schedule established by the Commission in an order issued on June 1, 2022. EKPC stated in its motion that it is making every effort to respond to the various requests for information in a timely fashion, but that it needed additional time in which to gather all of the information requested and prepare its responses due to the nature and number of requests. EKPC further stated that it had contacted all intervenors, and that no intervenors objected to its request for additional time to file its responses as long as the procedural schedule was revised accordingly and the date for the final hearing remained the same. EKPC requested an additional eight days in which to file its responses, which would move the due date for its responses to July 29, 2022, and that the other prehearing procedural events be adjusted accordingly, but that the date for the hearing remain the same. No intervenors filed a response objecting to EKPC's motion for an extension.


The Commission finds that good cause has been shown to grant EKPC's motion. The Commission recognizes that the requests served on EKPC were extensive and often

dealt with complex modeling issues, and notes that the extension will not result in prejudice to any party or require changing the hearing date. Thus, the Commission shall extend the due date for EKPC to file its responses to the requests for information as requested, and shall similarly extend the dates for filing supplement requests for information, responses to supplemental requests for information, and prehearing comments as indicated in the procedural schedule set forth in the Appendix to this Order. The original hearing date of December 13, 2022, and procedural dates following the hearing shall remain the same.

IT IS HEREBY ORDERED that:

1. EKPC's motion for extension of time is granted.
2. EKPC shall submit its responses to all initial requests for information no later than July 29, 2022.
3. The procedural schedule set forth in the Appendix to this Order shall be followed with respect to the prehearing procedural events identified therein.
4. The June 1, 2022 Order in this matter shall remain in full force and effect except as stated herein.
