ORDER

On December 7, 2022, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, and Mountain Association (Joint Intervenors) moved the Commission to admit *pro hac vice* Cassandra McCrae and Thomas Cmar.

Ms. McCrae is an attorney whose office is in Pennsylvania and is seeking to practice law before the Commission on behalf of Joint Intervenors in association with Ashley Wilmes, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request, Ms. McCrae has shown that she is a member in good standing of another state bar and has been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). In addition, Ms. McCrae filed evidence that she paid the fee required by the Kentucky Bar Association pursuant to Kentucky Supreme Court Rule 3.030 and was assigned a *pro hac vice* number.

Mr. Cmar is an attorney whose office is in Ohio and is seeking to practice law before the Commission in this case on behalf of Joint Intervenors in association with Ashley Wilmes, an attorney licensed to practice law in the Commonwealth of Kentucky. In support of the request, Mr. Cmar has shown that she is a member in good standing of another state bar and has been certified to practice before the Commission by the

Kentucky Bar Association under Supreme Court Rule 3.030(2). In addition, Mr. Cmar filed evidence that she paid the fee required by the Kentucky Bar Association pursuant to Kentucky Supreme Court Rule 3.030 and was assigned a *pro hac vice* number.


IT IS THEREFORE ORDERED that

2. Cassandra McCrae and Thomas Cmar shall comply with the rules of the Commission and the Kentucky Bar Association.


