ORDER

A hearing in the above-styled matter was held on Tuesday, December 13, 2022. Commission Staff's counsel and counsel for certain intervenors requested to file post-hearing data requests. Counsel for certain parties also requested leave to file supplemental comments based on information obtained at the hearing or in post-hearing data requests before Commission Staff issues its report in this matter, and counsel for East Kentucky Power Cooperative, Inc. (EKPC) requested leave to file supplemental comments in response to intervenors' supplemental comments, if any. The Commission also finds that all parties should have the ability to comment on Commission Staff's report in this matter before this case is closed. However, in order to accommodate those procedural events, the deadline for Commission Staff to file its report on EKPC's 2022 IRP, which was established as January 18, 2023, in the June 1, 2022 Order in this case, will need to be extended.

IT IS THEREFORE ORDERED that:

1. Post-hearing data requests to EKPC, if any, shall be filed on or before December 22, 2022.

2. Responses to post-hearing data requests shall be filed on or before January 20, 2023.

3. Any party shall file supplemental post-hearing comments, if any, on or before February 3, 2023.

4. Any party shall file their response, if any, to other parties' supplemental post-hearing comments on or before February 17, 2023.

5. Commission Staff's Report on EKPC's 2022 Integrated Resource Plan shall be filed into the record no later than February 28, 2023.

6. Any party desiring to file written comments regarding Commission Staff's Report shall do so no later than March 21, 2023.

7. The June 1, 2022 Order in this matter shall remain in effect except as stated herein.


