ORDER

On December 16, 2022, the Commission entered an Order establishing a post-hearing procedural schedule. The procedural schedule, among other things, required that post-hearing response comments, if any, be filed by February 17, 2023; that Commission Staff's Report on EKPC's 2022 Integrated Resource Plan be filed into the record no later than February 28, 2023, that any party desiring to file written comments regarding Commission Staff's report do so no later than March 21, 2023. However, given the tight schedule and other obligations, Commission Staff need additional time to complete their report in this matter. For that reason, the Commission, on its own motion, finds that the procedural schedule established on December 16, 2022, should be amended to extend the deadline for Commission Staff's report and for comments on Commission Staff's report by ten days. The amended procedural schedule is attached as an Appendix to this Order.

IT IS THEREFORE ORDERED that:

1. The procedural schedule established on December 16, 2022, is amended.
2. The amended procedural schedule set forth in the Appendix to this Order shall be followed.

3. All provisions of the Commission's Order of December 16, 2022, in conflict with the provisions of this Order are vacated. All other provisions of the December 16, 2022 Order not in conflict shall remain in effect.
