ORDER

On April 1, 2022, East Kentucky Power Cooperative, Inc. (EKPC) filed its 2022 Integrated Resource Plan (IRP) pursuant to 807 KAR 5:058. By Order issued on March 9, 2023, the Commission entered into the record of this case a report summarizing Commission Staff's review (Staff Report) of EKPC's 2022 IRP. A hearing was conducted in this matter on December 13, 2022. By Order issued March 16, 2023, all parties were granted the opportunity to file final written comments regarding the IRP or Staff Report no later than March 31, 2023. Based on the evidence of record and being sufficiently advised, the Commission finds that all substantive actions in this case have been completed and this case shall be closed, and that EKPC's next IRP shall be filed on or before April 1, 2025.


IT IS THEREFORE ORDERED that:


