ORDER

The Commission, on June 3, 2022, issued an Order that, *inter alia*, required the parties to this case to file a statement regarding their position on briefing, including order and timing, and whether they deemed briefs necessary. No party has requested a hearing.

The Kentucky Broadband and Cable Association (KBCA) is the only party that affirmatively requested a briefing schedule. KBCA proposed that the Commission allow for simultaneous opening briefs, followed by simultaneous response briefs. While other parties stated that briefs are not necessary, the Commission finds that simultaneous briefs and response briefs are necessary to complete the record in this matter. However, the Commission also finds that a party is not required to file a brief. Upon the filing of the response briefs, the case will be submitted to the Commission for a decision based upon the record.

IT IS THEREFORE ORDERED that:

1. Any initial brief shall be filed no later than October 11, 2022.
2. Any response brief shall be filed no later than October 18, 2022.

3. Upon the filing of response briefs, the case shall stand submitted to the Commission for a decision.


