ORDER

On June 3, 2022, the Commission issued an Order opening this proceeding. The case style and Order contained incorrect dates for the environmental surcharge expense periods under review and the incorrect review periods in Commission Staff's First Request for Information to East Kentucky Power Cooperative, Inc. (Staff's First Request to EKPC), Items 3, 4, and 5, which were attached as Appendix B to the June 3, 2022 Order.

Finding that the June 3, 2022 Order shall be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The case style is amended to read:

An Electronic Examination by the Public Service Commission of the Environmental Surcharge Mechanism of East Kentucky Power Cooperative, Inc. for the Sixth-Month Expense Periods Ending November 30, 2019, May 31, 2020, November 30, 2020, and November 30, 2021, the Two-Year Expense Period

Ending May 31, 2021, and the Pass-Through Mechanism of
Its Sixteen Member Distribution Cooperatives

2. The first full paragraph on page 2 of the Order is stricken and is replaced with the following language:

On its own motion, the Commission initiates (1) the six-month review of EKPC's environmental surcharge for expense months ending November 30, 2019, May 31, 2020, November 30, 2020, and November 30, 2021; (2) the corresponding six-month reviews of Member Cooperatives' pass-through mechanism for expense months ending November 30, 2019, May 31, 2020, November 30, 2020, and November 30, 2021; (3) the two-year review of EKPC's environmental surcharge for the expense month ending May 31, 2021; and (4) the corresponding two-year reviews of Member Cooperatives' pass-through mechanism for the expense month ending May 31, 2021.

3. Appendix B, , Staff's First Request to EKPC, the second sentence in Item 3 is stricken and is replaced with the following language:

Refer to Form 2.3, Inventory and Expense of Emission Allowances, for each of the expense months under review.

4. Appendix B, Staff's First Request to EKPC, Item 4 is stricken and is replaced with the following language:

This question is addressed to EKPC. Refer to Form 2.5, Operating and Maintenance Expenses, for the expense months under review. For each of the expense account numbers listed on this schedule, explain the reason(s) for any change in the expense levels from month to month if that change is greater than plus or minus 10 percent.

5. Appendix B, Staff's First Request to EKPC, the last sentence in Item 5 is stricken and is replaced with the following language:

Provide the following information as of November 30, 2021.

6. All other provisions of the Commission's June 3, 2022 Order that are not in conflict with the terms of this Order shall remain in effect.
