Good Morning-

My name is Kenny Wilson, County Judge Executive for Hickman County, Ky. I see where the Clinton Water Service is asking for an increase in rates for Clinton, Ky. the county seat of Hickman County. I understand costs have gone up but we would like more cooperation and help especially in the area of economic development from Clinton Water Service.

We have a 50 acre tract of land that joins the Clinton city limits in which KYTC has funded an entrance for economic development. This is a rail served site that has all utilities except water. In talking with Clinton Water Service, we got no response in trying to provide water to this site. They have a six inch main about 400 yards away and could run an eight inch line from city wells about three quarters of a mile away. Our hope is that they would make an investment in our community if they plan on being here in the future.

Again, we understand costs have risen but they have a track record of asking for high rate increases every time they appear before the Public Service Commission. If you could help us in encouraging assistance from them for economic development, it sure would be appreciated.
