ORDER

On July 15, 2022, Kentucky Power Company (Kentucky Power) filed a motion for leave to withdraw its application in this proceeding. Kentucky Power requested to withdraw the application without prejudice to refile at a later date and without prejudice to seek related relief. As a basis for its motion, Kentucky Power stated that it determined it was not “in the best interest” of Kentucky Power to proceed with this case at this time.

Based upon a review and the case record, the Commission finds that Kentucky Power established good cause to grant its request to withdraw the application without prejudice to refile at a later date. The Commission also finds that the August 30, 2022, hearing in this matter shall be canceled. Kentucky Power initiated this proceeding to approve a tariff amendment and granting the request to withdraw the application allows the current tariff to remain in effect as previously approved by the Commission.

IT IS THEREFORE ORDERED that:

1. Kentucky Power’s motion to withdraw the application without prejudice is granted.


2. The August 30, 2022 hearing in this matter is canceled.
