ORDER

On July 28, 2022, the Commission issued an Order approving the Gas Cost Recovery (GCR) rates for Kentucky Frontier Gas, LLC (Kentucky Frontier) for service rendered on and after August 1, 2022. The Commission approved a correct GCR rate of \$10.1395 per Mcf but made an error in converting the GCR rate into Ccf. The Order states the incorrect GCR rate as \$0.101395 per Ccf while the actual converted rate is \$1.01395 per Ccf. The error did not have an impact on the GCR as approved by the Commission in the July 28, 2022 Order.

Finding that the July 28, 2022 Order shall be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Based upon the calculations above, the Commission finds that Kentucky Frontier's corrected GCR rate is \$0.101395 per Ccf or \$10.1395 per Mcf, which is an increase of \$1.8038 per Mcf from its previous rate of \$8.3357 per Mcf is stricken and is replaced with the following language:

Based upon the calculations above, the Commission finds that Kentucky Frontier's corrected GCR rate is \$1.01395 per Ccf or \$10.1395 per Mcf, which is an increase of \$1.8038 per Mcf from its previous rate of \$8.3357 per Mcf.

2. Appendix to the July 28, 2022 Order is stricken and is replaced with the following language:

The Gas Cost Recovery rate shall be \$1.01395 per Ccf for service rendered on and after August 1, 2022.

3. All other provisions of the Commission's July 28, 2022 Order that are not in conflict with the terms of this Order shall remain in effect.
