The Commission received your email request made in accordance with 807 KAR 5:026, Section 9(1)(a)(2) requesting the highest average volumetric rate of a local gas distribution utility approved by the Commission, in accordance with KRS Chapter 278 and 807 KAR Chapter 5, that will be in effect for May 2023.

The requested information is set forth below.

In accordance with 807 KAR 5:026, Section 9(1)(a)(2), the highest prevailing gas rate approved by the Commission as of the date of this letter is \$23.7756 per mcf. The highest prevailing gas rate approved by the Commission for rates effective in May 2023 may differ from this rate, but those rates are not yet approved by the Commission and thus not in accordance with the express language of 807 KAR 5:026, Section 9(1)(a)(2).
