Pursuant to an order issued on February 7, 2025, an informal conference (IC) was conducted on February 21, 2025. Attached is a copy of the attendance roster.

Parties from East Kentucky Midstream, LLC (EKM) and Kentucky Frontier Gas, LLC (Kentucky Frontier) and the Attorney General's office introduced themselves.

The stated purpose of the IC was to discuss whether mediation would be a useful tool for Kentucky Frontier and EKM to resolve this case.
