## ORDER

The Commission, on its own motion, finds, having canceled the February hearing date, a new hearing date is needed to resolve this matter.

The Commission finds that a hearing in this matter should be held on May 19, 2025, at 9 a.m. Eastern Daylight Time and continuing until called from the bench by the presiding officer, at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

Additionally, any hearing scheduled in this matter shall be held on the designated day or days and continued until called from the bench by the presiding officer. Pursuant to 807 KAR 5:001, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing. Hearings are held at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. East Kentucky Midstream, LLC (East Kentucky Midstream) shall give notice of this hearing pursuant to 807 KAR 5:001 Section 9(2). Witnesses who sponsored schedules, testimony, or responses to requests for information

are expected to participate in person at a hearing. In addition, any person who provided a sworn deposition in this matter shall appear in person at this hearing.

Finally, the Commission finds that, due to the complexity of this matter, several other procedural guidelines should be established. Any motions related to the hearing shall be filed no less than ten days prior to the hearing. Witness lists shall be filed no less than 21 days prior to the hearing date. The Commission will not look favorably upon requests made after these deadlines have passed. Commission Staff should make available for testimony, Commission consulting expert Lindsey Sander and Dewayne Sims, with Sander Consulting.

## IT IS THEREFORE ORDERED that:

- 1. A hearing in this matter shall be held on May 19, 2025, at 9 a.m. Eastern Daylight Time and continuing until called from the bench by the presiding officer, at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
- 2. East Kentucky Midstream shall give notice of any scheduled hearing in accordance with the provisions set forth in 807 KAR 5:001, Section 9(2). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov" and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listing on the PSC website, psc.ky.gov." At the time publication is requested, East Kentucky Midstream shall forward a duplicate of the notice and request to the Commission.
- 3. At any public hearing in this matter, neither opening statements nor summarization of direct testimonies shall be permitted.

- 4. No new information shall be entered into evidence as the result of direct examination at the hearing.
- 5. Any hearing scheduled in this matter shall be held on the designated day or days and continued until called from the bench by the presiding officer. Pursuant to 807 KAR 5:001, Section 2, if the hearing is not concluded on the designated day, the hearing shall be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.
- 6. Witnesses who sponsor schedules, testimony, or responses to requests for information shall participate in person at any hearing scheduled in this matter.
- 7. All persons who were deposed in this matter shall be appear in person at the hearing scheduled in this matter.
  - 8. All parties shall file a witness list at least 21 days prior to the hearing date.
- 9. All parties shall file any motions related to the hearing at least ten days prior to the hearing scheduled in this matter.
- 10. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video recording shall be made of the hearing.
- 11. The Commission does not look favorably upon motions for continuance. Accordingly, motions for extensions of time with respect to the schedule herein shall be made in writing, within the prescribed time frame, and will be granted only upon a showing of good cause.
- 12. The Commission does not look favorably upon motions to excuse or substitute witnesses from testifying at Commission hearings. Accordingly, motions to

excuse or substitute a witness from testifying at a Commission hearing or from testifying in person at a Commission hearing shall be made in writing, at least ten days prior to the hearing scheduled in this matter, and will be granted only upon a showing of good cause.
