ORDER

The Commission, on its own motion, establishes this docket to address pressing issues related to utilities impacted by a severe weather event in Eastern Kentucky. Pursuant to Executive Order 2022-457, there exists a state of emergency arising from a severe weather system that, beginning on July 26, 2022, generated “multiple rounds of heavy torrential rain, creating flooding, flash flooding, mudslides, and landslides.”<sup>1</sup>

The Commission, pursuant to KRS 278.040(1), regulates utilities in this state and has the authority to enforce the provisions of KRS Chapter 278. Additionally, pursuant to KRS 278.040(2), the Commission has exclusive jurisdiction over the rates and services of the utilities in the Commonwealth. The Commission has "the plenary authority to regulate and investigate utilities" pursuant to both KRS 278.030 and KRS 278.040.<sup>2</sup>

Pursuant to the Commission's statutory and plenary authority, the Commission finds any utility impacted by the severe weather event that is required to make monthly, quarterly, semi-annual, or annual filings pursuant to a Commission Order between July 28, 2022 and September 6, 2022, shall have a 30 day extension to file the report. Commission requests, but does not require, that any utility extending the filing date for a report notify the Commission by submitting a letter or email to [PSCED@ky.gov](mailto:PSCED@ky.gov), including the case number, or by leaving a voice mail with Nancy J. Vinsel, General Counsel, at 502-782-2582, and Staff will file notice into that case record.

Because this matter arises from a state of emergency due to a severe weather event, if a utility impacted by the severe weather event needs additional time to file a report or has any other request to make to the Commission, the Commission finds that, pursuant to 807 KAR 5:001, Section 22, good cause exists to allow such utilities to deviate from the motion practice regulation in 807 KAR 5:001, Section 5, and to deviate from the electronic filing requirement in 807 KAR 5:001, Section 8(2), which requires a utility to file notice of its intent to use electronic filing procedures prior to filing its application.

The Commission further finds that all jurisdiction utilities shall be served with a copy of this Order.

IT IS THEREFORE ORDERED that:

1. Any utility impacted by the severe weather event beginning on July 26, 2022, shall have a 30 day extension, from the date of this Order, to file any monthly, quarterly, semi-annual, or annual filings required pursuant to a Commission Order that otherwise would be filed between July 28, 2022 and September 6, 2022.
2. Until September 6, 2022, utilities impacted by the severe weather event beginning on July 26, 2022, are granted deviation from the following requirements:
  - a. 807 KAR 5:001, Section 5; and
  - b. 807 KAR 5:001, Section 8(2).
3. This matter is closed and removed from the Commission's docket.
