ORDER

On February 21, 2023, Cumberland County Water District (Cumberland District) filed a motion to continue the hearing date set for February 23, 2023. As grounds for the continuance, Cumberland District stated that notice of the hearing would not be published in the *Cumberland County News* in conformity and compliance with 807 KAR 5:001E, Section 9(2)(b). Cumberland District also stated that two members of the Board of Commissioners and counsel had scheduling conflicts for the hearing date.

The Commission finds that the failure to comply with 807 KAR 5:001E, Section 9(2) constitutes good cause to continue the hearing. The Commission further states that Cumberland District must ensure that notice is published in a timely fashion when the Commission issues a scheduling Order containing a new date.

1. The motion to continue the hearing date from February 23, 2023, is granted.


