ORDER

On February 6, 2022, Duke Energy Kentucky, Inc. (Duke Kentucky) filed a motion requesting that the Commission schedule an informal conference (IC) for the purpose of discussing the status of the case and possible settlement and resolution of any issues with the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention.

Based upon the motion, the Commission finds that Duke Kentucky established good cause to schedule an IC, and therefore the motion is granted. The parties to the case are cautioned that the Commission speaks solely through its Orders and that any resolution of issues between parties will be considered, but is not binding on the Commission.
