## ORDER

On February 9, 2023, Duke Energy Kentucky, Inc. (Duke Kentucky) filed a motion requesting that the hearing scheduled for February 22, 2023, at 9 a.m. Eastern Standard Time be continued so that Duke Kentucky and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) can reach settlement and determine what unresolved issues remain for hearing. On February 15, 2023, Duke Kentucky filed an amendment to its February 9, 2023 motion and stated that Duke Kentucky and the Attorney General will be able to finalize a settlement for filing on or before March 10, 2023. Further, Duke Kentucky's motion indicated that the Attorney General has no objection to this request.

The Commission finds that good cause has been established to grant a continuance. A hearing will be more useful if the parties have identified settled issues and unresolved issues ahead of time.

## IT IS THEREFORE ORDERED that:

1. Duke Kentucky's motion to amend the procedural schedule and continue the hearing is granted.

- 2. The hearing scheduled for February 22, 2023 at 9 a.m. Eastern Standard Time in this matter is canceled and is rescheduled for March 28, 2023, at 9 a.m. Eastern Daylight Time and continuing until called from the bench by the presiding officer, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
- 3. Pursuant to 807 KAR 5:001E, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.
- 4. Witnesses who sponsor schedules, testimony, or responses to data requests shall participate in person at the hearing.
- 5. Duke Kentucky shall give notice of the hearing in compliance with 807 KAR 5:001E, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov"; and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov." At the time the notice is mailed or publication is requested, Duke Kentucky shall forward a duplicate of the notice and request to the Commission.
- 6. Pursuant to KRS 278.360 and 807 KAR 5:001E, Section 9(9), a digital video transcript shall be made of the hearing.
