An informal conference (IC) was conducted on March 15, 2023. Attached is a copy of the attendance roster.

Duke Energy Kentucky, Inc. (Duke Energy) and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) filed a motion for an IC on March 9, 2023. The stated purpose of the IC was to discuss settlement between Duke and the Attorney General.

The parties indicated that the previously discussed settlement was not achieved, and that in the hearing in this matter the parties would focus on witness testimony as opposed to planned settlement stipulations.

The parties also discussed Duke's pending motion for virtual examination of one of its witnesses.
