ORDER

On July 21, 2023, the Commission granted Rowan Water Inc.’s (Rowan Water) request to allow virtual participation for its Chairman, Larry Johnson.<sup>1</sup> As part of that Order, the Commission ordered that “[b]y July 28, 2023, counsel for Rowan Water shall arrange a technology test with Commission Staff to ensure that all required technology is working properly.”<sup>2</sup> On July 27, 2023, Rowan Water, Inc. (Rowan Water) filed a motion for extension of time. According to the motion, counsel reached out to set up the technology test and was told it could not be done until July 28, 2023. However, Mr. Johnson was unavailable, due to his wife’s surgery, on that date. Rowan Water, Mr. Johnson and Staff have set a technology test up for July 31, 2023. Rowan Water requested an extension to comply with the Order until July 31, 2023.

The Commission finds that there is good cause to grant the extension. The Order was issued on a Friday; the Commission recognizes that there were hearings scheduled for four out of five days the week of July 24, 2023. The Commission believes that Mr. Johnson and Rowan Water were diligent in attempting to set-up a time for a technological test.

IT IS HEREBY ORDERED that:

1. Rowan Water's motion is granted.
2. Rowan Water shall have until the close of business on Monday, July 31, 2023, to complete the technological test for Mr. Larry Johnson.
