

ORDER

This matter arises from an issue the Commission ruled upon at the November 28, 2022 hearing in this case. On November 21, 2022, Kentucky Power Company (Kentucky Power) moved the Commission to admit *pro hac vice* Kenneth Tillotson, an attorney whose office is in Missouri, to practice law before the Commission on behalf of Kentucky Power in association with Katie M. Glass, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request Kenneth Tillotson has shown that he is a member in good standing of the Oklahoma bar and has been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). In addition, Kenneth Tillotson has agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that Kenneth Tillotson is admitted *pro hac vice* for the purpose of representing Kentucky Power in association with Katie M. Glass in the above-styled proceeding, provided that Katie M. Glass or another member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.
