ORDER

On September 16, 2022, Valley Gas, Inc. (Valley Gas) tendered an application with the Commission, pursuant to 807 KAR 5:076, requesting to adjust its rates, and after Valley Gas cured a number of deficiencies, the application was accepted and deemed filed on October 24, 2022.¹ A procedural schedule was issued on November 22, 2022. Due to scheduling conflicts and the need to develop a robust record, the November 22, 2022 procedural schedule was subsequently amended on February 17, 2023.

Due to the need to further develop a robust record, the Commission, on its own motion, finds that the procedural schedule established on November 22, 2022, and amended on February 17, 2023, should be amended to extend the date for Commission Staff to file a report (Commission Staff's Report) from April 14, 2023, to May 31, 2023.

After the Commission Staff's Report is filed on or before May 31, 2023, Valley Gas will have 14 days to file a written response to the Commission Staff's Report.² If Valley

Gas does not file written objections to a finding contained in the Commission Staff's Report within 14 days after the date of service of the Commission Staff's Report, Valley Gas will be deemed to have waived all objections to that finding.³

IT IS THEREFORE ORDERED that:

- The procedural schedule established on November 22, 2022, and amended on February 17, 2023, is amended to extend the date to file the Commission Staff's Report.
 - 2. Commission Staff's Report shall be filed no later than May 31, 2023.
- Valley Gas shall file its written response, if any, to the Commission Staff's
 Report within 14 days of service of Commission Staff's Report.
- 4. All provisions of the November 22, 2022 procedural schedule, as amended on February 17, 2023, not in conflict with this Order shall remain in effect.
