INTRA-AGENCY MEMORANDUM

KENTUCKY PUBLIC SERVICE COMMISSION

RE: Informal Conference of November 29, 2022

Pursuant to an order issued on November 28, 2022, an informal conference (IC) was conducted on November 29, 2022. Attached is a copy of the attendance roster.

Kentucky-American Water Company (Kentucky-American) filed a motion for an IC on November 23, 2022. The purpose of the IC was to clarify the information requested in Commission Staff's Second Request for Information (Staff's Second Request) to Kentucky-American. Staff's Second Request, Item 2, referred to Commission Staff's First Request for Information, Item 2, which sought an update to Exhibit 2, Table 4 to the testimony of Brent E. O'Neill in Case No. 2018-000358, which showed material types for water mains separated by construction periods. Staff's Second Request, Item 2 asked that this data be further separated out by Qualified Infrastructure Program (QIP) Year 1 and Year 2 water main replacements.

Kentucky-American engineering staff asked how Commission Staff wanted the table updated. Commission Staff responded that the information being sought in Staff's Second Request, Item 2, was the change in material type of existing water main from pre-QIP to QIP Year 1, QIP Year 2, and planned QIP Year 3 to determine if water mains of certain material types were being prioritized as part of the replacement plan and whether these priorities aligned with the original intent of the QIP plan. Commission Staff recommended providing separate columns to the table showing the material types that were replaced for each of these four periods.

Kentucky-American engineering staff noted that there were insufficient plant records to itemize the water main data between replacements and additions for data not related to the QIP replacement projects. Commission Staff indicated that Kentucky-American could separately state the data related to the QIP and that would sufficiently respond to the request.

There being no further discussion, the IC was then adjourned.
