Dear Governor Beshear:

As the Chairman of the Kentucky Public Service Commission (PSC), I also serve as the Chairman of the Kentucky State Board on Electric Generation and Transmission Siting (Siting Board). Therefore, it is my duty to inform you that, on November 28, 2022, the Siting Board received an application from Martin County Solar Project, LLC requesting approval to transfer a certificate of construction previously granted by the Siting Board Case No. 2021-00029 in Martin County, Kentucky.

The five permanent members of the Siting Board are myself and the other members of the PSC; the Secretary of the Energy and Environment (or her designee);¹ and the Secretary of the Economic Development Cabinet (or his designee).²

In accordance with KRS 278.702(1)(d)(1)(b), I am requesting that you please make the requisite appointment of a Martin County resident as an ad hoc public member to the Siting Board for this matter.
