Dear Mr. Lafferty:

As the Chairman of the Kentucky Public Service Commission (PSC), I also serve as the Chairman of the Kentucky State Board on Electric Generation and Transmission Siting (Siting Board). Therefore, it is my duty to inform you that, on November 28, 2022, the Siting Board received an application from Martin County Solar Project, LLC requesting authorization to transfer a portion of its construction certificate granted in Case No. 2022-00362 to Martin County Solar Project, LLC.

The permanent members of the Siting Board are myself and the other members of the PSC; the Secretary of the Energy and Environment (or her designee);¹ and the Secretary of the Economic Development Cabinet (or his designee).²

In addition to the permanent members of the Siting Board, pursuant to KRS 278.702(1)(d)(1), one of the Siting Board ad hoc members is the chairman of the planning commission with jurisdiction over the area in which the facility will be located. KRS 278.702(1)(d)(1) also provides that if the jurisdiction has no planning commission, the Judge Executive shall serve as an ad hoc member of the Siting Board.
