We received a request for information regarding Case#: 2022-00363. This request was sent out to all jurisdictional utilities. Anderson Oil Ltd, aka Anderson Oil & Gas (3320) is no longer deemed to be under PSC jurisdiction. As of November 11, 2019, we received notification that we are no longer subject to PSC jurisdiction since a 2" gas line in our system was deemed to be incidental gathering, and not intrastate transmission, which had placed us under the jurisdictional category. I have attached copies of the letter to us as well as the determining inspection from PSC personnel regarding that determination.

Anderson Oil Ltd continues to participate and is a member (0309) in the 811 notification program to insure that 3<sup>rd</sup> party contractors remain safe while working around our natural gas gathering lines.

However, in response to request for information we submit the following:

- A: We have received 12 normal locate requests (811 notifications) since January 1, 2022
- B: Contractors have sent 2 second notice (811 notifications)
- C: None of the requests involved any of our facilities. We responded with no conflict responses on 811 websites; Exactix pre Oct 1, 2022, and OCCINC post Oct. 1, 2022.
- D: Not applicable since all requests did not involve our facilities.
- E: Not applicable since all requests did not involve our facilities.

Re: Anderson Oil & Gas Jurisdictional Status

Dear Mr. Sanders:

In past inspections, the Kentucky Public Service Commission has treated Anderson Oil and Gas' 2" pipeline in Whitley County as intrastate transmission.

On November 6, 2019 a field visit was conducted to review the operations for jurisdictional determination. At the time of the visit, the compressor and pipeline were located in a remote area with no dwellings intended for human occupancy in the immediate area.


After the field review, Commission staff consulted a PHMSA interpretation letter (PI-09-0008) dated July 30, 2009, and reviewed RP-80. Commission staff have determined the 1,800' of 2" steel from the outlet of compressor to the Delta gas tap should be treated as incidental gathering.

Safety remains priority with the Commission. PSC Staff recommends that Anderson Oil & Gas continue to maintain their cathodic protection systems and conduct leakage surveys.
