## ORDER

On March 10, 2023, the Commission issued an Order containing a procedural schedule in the matter of Mountain Water District's (Mountain District) application for an adjustment of sewer rates. Included as an Appendix to the March 10, 2023 Order is Commission Staff's First Request for Information (Staff's First Request), for which Mountain District's responses were due by April 10, 2023. Mountain District has failed to submitted information in response to Staff's First Request to date.

The Commission would note that Mountain District has also filed for an adjustment of its water rates in Case No. 2022-00366.<sup>1</sup> Mountain District has filed its responses to Commission Staff's First Request for Information in Case No. 2022-00366 on March 20, 2023.

The Commission accordingly concludes that, to keep both of Mountain District's rate cases on the same schedule, the procedural schedules in both cases should be amended for Mountain District to respond to Staff's First Request in this sewer rate case

within the timeline provided, and to allow for Commission Staff to process further requests for information to Mountain District in both cases moving forward.

#### IT IS THEREFORE ORDERED that:

- The amended procedural schedule set forth in the Appendix to this Order shall be followed.
- 2. Mountain District shall respond to all requests for information propounded by Commission Staff, whether identified on the procedural schedule or otherwise, as provided in those requests.
- 3. The Commission does not look favorably upon motions for continuance. Accordingly, motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
- 4. All provisions of the Commission's Order of March 10, 2023, in conflict with the provisions of this Order are vacated. All other provisions of the Order of March 10, 2023, shall remain in effect.
