ORDER

On January 26, 2023, Kentucky Broadband and Cable Association (KBCA) moved the Commission to admit *pro hac vice* Paul Werner, an attorney whose office is in Washington, D.C., Maria-Laura Coltre, an attorney whose office is in Washington D.C., and Hannah Wigger, an attorney whose office is in Washington D.C., to practice law before the Commission on behalf of KBCA in association with Todd Osterloh, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request, Paul Werner, Maria-Laura Coltre, and Hannah Wigger have shown that they are members in good standing of another state bar and have provided proof that the *pro hac vice* fee has been tendered to the Kentucky Bar Association. In addition, Paul Werner, Maria Laura Coltre, and Hannah Wigger have agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that Paul Werner, Maria-Laura Coltre, and Hannah Wigger are admitted *pro hac vice*, pending proof of their Kentucky *pro hac vice* numbers are provided within ten days of service of the Order, for the purpose of representing KBCA

in association with Todd Osterloh in the above-styled proceeding, provided that Todd Osterloh or another member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.


