ORDER

On January 23, 2023, Sierra Club moved the Commission to admit *pro hac vice* Kathryn Huddleston, an attorney whose office is in Austin, Texas, and Joshua Smith, an attorney whose office is in Oakland, California, to practice law before the Commission on behalf of Sierra Club in association with Joe Childers, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request, Kathryn Huddleston and Joshua Smith have shown that they are members in good standing of another state bar and have been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). In addition, Kathryn Huddleston and Joshua Smith have agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that Kathryn Huddleston and Joshua Smith are admitted *pro hac vice* for the purpose of representing Sierra Club in association with Joe Childers in the above-styled proceeding, provided that Joe Childers or another member

of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.


