ORDER

On April 28, 2023, Sierra Club moved the Commission to admit *pro hac vice* Kristin Henry, an attorney whose office is in Oakland, California, to practice law before the Commission on behalf of Sierra Club in association with Joe Childers, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request, Kristin Henry has shown that she is a member in good standing of another state bar and has provided proof that a *pro hac vice* fee has been tendered to the Kentucky Bar Association. However, it does not list Kristin Henry or her *pro hac vice* Kentucky bar number. In addition, Kristin Henry has agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that Kristin Henry is admitted *pro hac vice*, pending proof, similar to that filed on behalf of Joshua Smith and Kathryn Huddleston, filed prior to the start of the hearing set in this case of admittance to the Kentucky Bar Association, for the purpose of representing Sierra Club in association with Joe Childers in the above-

styled proceeding, provided that Joe Childers or another member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.


