ORDER

On October 24, 2023, the Commission issued an Order in this matter addressing the confidentiality petition filed by Duke Kentucky on May 4, 2023, relating to its responses to Kroger’s First Request for Information. The Order erroneously listed Duke Kentucky’s Budget Guidelines and Assumptions in the materials granted confidential treatment on page five of the Order.

Finding that the October 24, 2023 Order shall be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Duke Kentucky’s Budget Guidelines and Assumptions are stricken from the list of materials granted confidential treatment on page five of the Order and the sentence should now read as follows:

The Commission finds that the designated material contained in Duke Kentucky’s FRS monthly managerial reports and its monthly Regulatory O&M and Capital Reports, Direct Testimony of Paul Halstead Attachments PLH 2 and PLH 3, Direct Testimony of Jake Stewart Attachments JSS 3(a) and 3(b), and Direct Testimony of Bruce Sailors Attachments BLS-3, BLS-4, BLS-6, and BLS-8 are records that meet the criteria for confidential treatment and should be exempted from public

disclosure pursuant to KRS 61.878(1)(c)(1) and 807 KAR 5:001, Section 13.

2. All other provisions of the Commission's October 24, 2023 Order that are not in conflict with the terms of this Order shall remain in effect.
