ORDER

On June 1, 2023, Mountain Association, Kentuckians for the Commonwealth Appalachian Citizens' Law Center, Sierra Club, and Kentucky Resources Council, Inc. (collectively, Joint Intervenors) moved the Commission to admit *pro hac vice* Hema Lochan, an attorney whose office is in New York, and Thomas Cmar, an attorney whose office is in Ohio, to practice law before the Commission on behalf of Joint Intervenors in association with Byron Gary, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request, Hema Lochan and Thomas Cmar have shown that they are members in good standing of another state bar and have been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). In addition, Hema Lochan and Thomas Cmar have agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that Hema Lochan and Thomas Cmar are admitted *pro hac vice* for the purpose of representing collectively Joint Intervenors in association with Byron Gary in the above-styled proceeding, provided that Byron Gary or another

member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.
