ORDER

On July 13, 2023, Kentucky Power Company (Kentucky Power) moved the Commission to admit Hector Garcia Santana, an attorney whose office is in Ohio, *pro hac vice* to practice law before the Commission on behalf of Kentucky Power in association with Katie M. Glass, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request, Hector Garcia Santana showed that he is a member in good standing of another state bar and that he has been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). In addition, Hector Garcia Santana has agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

This motion was addressed at the beginning of the hearing on July 20, 2023, at which point the Commission indicated that it would grant the motion and that an Order would be forthcoming. Hector Garcia Santana was allowed to participate at the hearing with a member of the Kentucky Bar Association as co-counsel. The Commission finds that this Order should now be entered formally granting Kentucky Power's motion to admit Hector Garcia Santana *pro hac vice* as of July 20, 2023.



Glass in the above-styled proceeding, provided that Katie M. Glass or another member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.
