ORDER

On March 16, 2023, Duke Energy Kentucky, Inc.'s (Duke Kentucky) filed a motion to amend the Commission's March 7, 2023 final Order issued in this proceeding that approved Duke Kentucky's Demand-Side Management (DSM) rates for electric and gas service.

As a basis for the motion, Duke Kentucky explained that it requested to amend the residential gas rate and three electric rates: residential, non-residential distribution, and transmission service. Duke Kentucky further explained that the March 7, 2023 Order approved the residential gas rate and two electric rates, residential and non-residential distribution, but the transmission service DSM rate had been inadvertently omitted.

Based upon a review of the motion and the March 7, 2023 Order, the Commission finds that the March 7, 2023 Order inadvertently omitted the transmission service DSM rate, which was approved by the Commission. For that reason, the Commission finds that Duke Kentucky's motion should be granted.

The Commission further finds that the rates set forth in the Appendix to this Order should be effective as of the first billing cycle of the month following the March 7, 2023 Order.

IT IS THEREFORE ORDERED that:

- 1. Duke Kentucky's motion to amend the March 7, 2023 Order is granted.
- 2. The Appendix attached to the March 7, 2023 Order is stricken and replaced with the Appendix attached to this Order.
- 3. The rates set forth in the Appendix to this Order are effective as of the first billing cycle of the month following the March 7, 2023 Order.
 - 4. All other provisions of the March 7, 2023 Order shall remain in effect.
