ORDER

On December 22, 2022, the Commission entered an Order establishing a procedural schedule.¹ On December 13, 2022, the non-attorney consultant on behalf of the McKinney Water District (McKinney District) filed a request for an extension of time to file responses to Commission Staff’s First Request for Information (Staff’s First Request), and on January 10, 2023, the Commission amended the procedural schedule at the request of the utility.² On January 6, 2022, McKinney District’s non-attorney consultant, who is assisting McKinney District, submitted a read first letter and a partial response to Staff’s First Request.³ In the read first letter, the utility requested an extension until February 20, 2023, to complete the responses to Staff’s First Request.⁴ As a basis for the extension, the consultant pointed to recent travels and also to “family medical emergencies of the McKinney District office staff as the reason for seeking the extension.”⁵

The Commission finds that an amended procedural schedule that extends the time for McKinney District to respond to Staff's First Request to February 20, 2023, and makes other necessary adjustments to ensure the orderly review of McKinney District's application, is appropriate. However, this is the second request for an extension of time in this case, and the Commission will not look favorably upon any further motions for continuances. The Commission also notes that a portion of the responses that were provided on February 6, 2023, are not in the format requested in Staff's First Request. The Commission reminds the utility to provide all responses in a thorough and responsive manner.

IT IS THEREFORE ORDERED that:

1. The procedural schedule established on December 22, 2022, and amended on January 10, 2023, is amended.
2. The amended procedural schedule set forth in the Appendix to this Order shall be followed.
3. McKinney District shall respond to all data requests issued by Commission Staff regardless of whether they appear on this procedural schedule.
4. The provisions of the Commission's Order of December 22, 2022, that are not inconsistent with this Order shall remain in full force and effect.
