ORDER

On March 14, 2023, Metropolitan Housing Coalition (MHC), Kentuckians for the Commonwealth (KFTC), Kentucky Solar Energy Society (KYSES), and Mountain Association (MA) (collectively, Joint Intervenors) moved the Commission to admit *pro hac vice* Cassandra McCrae, an attorney whose office is in Pennsylvania, Gilbert Zelaya, an attorney whose office is in New York, and Thomas Cmar, an attorney whose office is in Ohio, to practice law before the Commission on behalf of Joint Intervenors in association with Ashley Wilmes, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case.

Based upon the motions, the Commission finds that Cassandra McCrae, Gilbert Zelaya, and Thomas Cmar have shown that they are members in good standing of another state bar and have been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). In addition, Cassandra McCrae, Gilbert Zelaya, and Thomas Cmar have agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that:

1. Cassandra McCrae is admitted *pro hac vice* for the purpose of representing Joint Intervenors in association with Ashley Wilmes in the above-styled proceeding, provided that Ashley Wilmes or another member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.


